December 4, 2017. Present were Mayor Elinor Carbone, Corporation Counsel Jaime LaMere, City Councilors Gregg Cogswell, Fred Simon, Marie Soliani and Frank Rubino. City Councilors Anne Ruwet and Paul Cavagnero were absent.

Mayor Carbone called the meeting to order at 6:30 p.m. starting with the Pledge of Allegiance.

Minutes

On a motion by Councilor Cogswell, seconded by Councilor Rubino, the Council voted unanimously to accept the minutes of the Regular Meeting held November 20, 2017. Councilors Soliani, Rubino and Simon abstained.

Open to Public

On a motion by Councilor Rubino, seconded by Councilor Cogswell, the Council voted unanimously to open the meeting to the public.

Mr. Roger Fulton spoke in favor of ordinance changes that may be proposed regarding the discharging of firearms.

Mr. Michael Banzurik shared his thoughts and research about the structure of the 'sewer enterprise' system and its connection fees.

Mayoral Appts.

On a motion by Councilor Cogswell, seconded by Councilor Soliani, the Council voted unanimously to accept the Mayor's re-appointment of Tom Stanton to the Northwest CT Transit District Board of Directors for a four-year term expiring July 1, 2021.

On a motion by Councilor Rubino, seconded by Councilor Soliani, the Council voted unanimously to accept the Mayor's re-appointment of Regular Member Gregory Mele and Alternate Member Donna Greco to the Planning & Zoning Commission for five-year terms expiring December 1, 2022.

On a motion by Councilor Cogswell, seconded by Councilor Rubino, the Council voted unanimously to accept the Mayor's re-appointment of Joel Perlotto and James Steck as Blight Task Force Hearing Officers for two-year terms to expire December 31, 2018; and as Zoning Citation Hearing Officers for two-year terms to expire September 30, 2019.

On a motion by Councilor Cogswell, seconded by Councilor Rubino, the Council voted unanimously to accept the Mayor's re-appointment of Fletcher Waldron as Sealer of Weights and Measures for a two-year term to expire December 15, 2019.

On a motion by Councilor Soliani, seconded by Councilor Cogswell, the Council voted unanimously to accept the Mayor's re-appointment of Kenneth Buckbee as Municipal Historian for a four-year term to expire December 15, 2021.

Release Liens

On a motion by Councilor Cogswell, seconded by Councilor Rubino, the Council voted unanimously to accept Corporation Counsel's recommendation and authorize the Mayor, pursuant to CGS §12-179, to release the lien described in Atty. LaMere's Memo dated December 4, 2017.

Tax Collector Tax Refunds
