# CITY OF TORRINGTON INLAND WETLANDS COMMISSION MEETING MINUTES April 12, 2022

### 1. <u>Call To Order:</u>

Chair Jay Bate, Jr., called the meeting to order at 7:00 p.m.; Room 218, City Hall Auditorium, 140 Main Street, Torrington, CT. The meeting was also held remotely via zoom online.

a. Show Cause Hearing

Mr. Ryan McEvoy, PE of SLR Engineering appeared via zoom to represent the applicant.

Mr. Leifert briefly reviewed what occurred at the March 2022 Inland Wetlands Commission meeting, and noted this activity was not deemed a significant activity. Paul Kundzins, City Engineer, had provided a positive review of this application.

#### 5. New Business:

a. Applicant: Torrington Historical Society

Location: John Brown Road (Assessor Map 213 Block 003 Lot 010)
Activity: Wetland crossing for hiking trail connecting the John Brown

Birthplace with Five Points Arts

Mark Linehan of the Torrington Trails Network appeared representing the applicant. Mr. Linehan explained their proposal to create a trail and wetland crossing connecting the John Brown Birthplace and Five Points Arts, at the former UCONN campus site. Mr. Linehan is working to obtain black locust wood for the walkway. Black locust wood is more costly than other types of lumber, and if not feasible to obtain it, there are other substitutions of lumber that have a shorter life span.

Mr. Linehan noted they will not be going through the watershed area, however the Torrington Water Company has required that pressure treated lumber not be used.

MOTION by Ms. Altman to accept the above referenced application, and that this is not a significant activity requiring a public hearing, motion seconded by Mr. Storti, unanimously carried.

b. Applicant: Crystal Gilbert and Michael Gillotti

Location: 2315 Torringford West Street

Activity: Construct new house and driveway crossing within regulated areas

Applicants Crystal Gilbert and Michael Gillotti appeared before the Commission and explained their proposal to construct a new house, which will need a driveway crossing over a small wetlands area, and work within the upland regulated area.

Mr. Leifert distributed maps for the Commission's review and provided further details on the proposed activity. An old paper road on the maps was discussed, and the applicants are in contact with their real estate attorney to address the status of the old paper road.

MOTION by Ms. Altman to accept the above referenced application, and that this is not a significant activity requiring a public hearing. Motion seconded by Mr. Storti and unanimously carried.

# 6. Staff Report:

a. Enforcement Report – update

Mr. Leifert noted there are no updates to report, other than the Show Cause Hearing matter on Felicity Lane, as previously discussed in agenda item 4a.

Mr. Leifert reported interviews have been held, and hopefully there should be a new staff member in the Land Use Office on board by the next Inland Wetlands Commission meeting.

Mr. Leifert briefly reviewed this agent determination permit that was issued.
