Thank you for your interest in the Community Development Stipend Program. This program was initiated in 2015 with the goal of supporting community organizations that make a positive impact in the City of Torrington.

A total of \$10,000 has been budgeted for this program and will be allocated in grants to the various organizations whose applications are approved. Funding is available to organizations in the City of Torrington who have a need to fund a specific project, program or initiative. Applications will be reviewed and scored by a committee consisting of the Mayor's Office and the city Treasurer. Applications will then be reviewed by the Small Cities subcommittee of the City Council before being approved by the full council.


