## **VETERAN MEMORIAL WALL UPDATE**

The Torrington Memorial Wall at City Hall will be updated with the Global War on Terror (Iraq & Afghanistan) Veterans in the future when hostilities cease. If you are a Veteran and served between October 2002 and the present date, were a Torrington resident when you entered the service, served at least 90 days active duty and were honorably discharged, you are eligible to be listed on the Memorial Wall.

Discharged Afghanistan and Iraq Veterans may contact the City Clerk's Office at any time to have their name added to the growing list. The same provisions apply as above. The dates of eligibility are October 2002 through December 2011 for Iraq, and October 7, 2001 to the present for Afghanistan. Those who have already contacted the City Clerk's Office and supplied their DD-214 do not need to contact the office again.

If you are eligible, contact the City Clerk's Office at 140 Main Street, Torrington, CT 06790. You must supply a DD-214 (Military Discharge) for proof of eligibility.
