## RE: Update on Blight Enforcement

Under the current ordinance, blight enforcement is complaint driven. Most complaints come from neighbors or residents that frequently pass the property in question or by city staff. The goal of blight enforcement is to bring the properties into compliance.

Attached hereto is a spreadsheet showing the blight enforcement activities that have occurred since the adoption of the new blight enforcement ordinance. You will find this report tracks the property by address. For your added information, the column heading "RVC" means a letter requesting voluntary compliance has been issued. The column heading "NOV" means a Notice of Violation warning letter citing the violations that are alleged to exist and remedial action required including the date the corrective action is required to be completed. "Citation letter" is the written notice that blight fines have commenced at the rate of \$100 per day because the property owner has not remediated the blighted conditions within the timeframe presented in the Notice of Violation.

The properties reported herein have been highlighted as follows:

Green – Properties for which a complaint has been investigated and enforcement actions resulted in compliance.

Yellow – Properties currently in various stages of blight enforcement proceedings.

Red - Properties that have been referred to Corporation Counsel for legal action (foreclosure).

As you read through this spreadsheet you will find that 98 properties have been investigated for blight, of which 42 have been brought into compliance, 48 are being actively pursued for blighted conditions and 8 have been referred to Corporation Counsel for legal proceedings.

As mentioned earlier in this memo, the goal of blight enforcement is compliance. Since my appointment as Blight Enforcement Officer, I have been successful in bringing approximately 50% of the properties into compliance.
