I respectfully request City Council accept the recommendation of the Deputy Public Works Director / City Engineer to authorize the Mayor to act on the behalf of the City regarding the award and execution of the contract agreement and all construction change orders for the project The Rehabilitation of Bogue Road Over The Naugatuck River CTDOT Bridge NO. 05059 BID # RBB 027-150622.

A price summary showing all bids received is enclosed. Upon a review of all bid submittal documents, **O&G Industries**, **Inc of Torrington CT** was determined to be the lowest responsive and responsible bidder with a total bid price of \$2,377,351.00.

I recommend the Mayor award this contract to **O&G Industries, Inc of Torrington CT** for the amount \$2,377,351.00 and allow for expenditures of up to \$237,735.00 for quantity fluctuation, contingencies and utility relocation.

The project work is comprised of the complete replacement of the existing bridge deck with precast concrete full depth panels, steel railings, abutment joints, link slab, waterproofing membrane, bituminous concrete wearing surface, replacement of bearing pads, girder repairs, minor structural modifications and backwall extensions, approach roadway reconstruction with drainage improvements, and installation of approach metal beam guide rails.

The project is funded by the City of Torrington Pavement Management Program Bond Fund and the Town of Harwinton according to State Statute 13a-100 cost sharing formula. (City of Torrington 85.26% and Town of Harwinton 14.74%.)
