A price summary showing all bids received is enclosed. Upon a review of all bid submittal documents, PAC Group, LLC of Torrington CT was determined to be the lowest responsive and responsible bidder with a total bid price of \$759,750.63.

I recommend the Mayor award this contract to **PAC Group, LLC of Torrington CT** for the amount **\$759,750.63** and allow for expenditures of up to **\$75,975.00** for quantity fluctuation and contingencies.

The project work is comprised of milling, and overlay paving including new concrete curbing, driveway aprons, adjustments and new catch basin and manhole tops and associated miscellaneous work. The streets included in this project are Aetna Avenue, Litchfield Street, Maple Street, Wyoming Avenue, and Zappulla Drive.

The project is funded by the City of Torrington Pavement Management Program Bond Fund.
