# MINUTES **CITY COUNCIL & WPCA** SPECIAL VIRTUAL MEETING November 7, 2022

A SPECIAL VIRTUAL MEETING of the City Council and Water Pollution Control Authority (WPCA) of the City of Torrington was held via Zoom on Monday, November 7, 2022. In attendance were Mayor Elinor Carbone, City Councilors Drake Waldron, Armand Maniccia, David Oliver, and Anne Ruwet. Economic Development Director Rista Malanca also joined the meeting. Councilors Paul Cavagnero and Keri Hoehne were absent.

Mayor Carbone called the meeting to order at 6:30 p.m.

### ARPA Façade and Building Improvements Grant – Round 2

On a motion by Councilor Ruwet, seconded by Councilor Maniccia, the Council, on the recommendation of the ARPA Committee, voted unanimously to approve the following Grant Application requests:

- a. Nutmeg Conservatory for the Arts, 58 Main Street, exterior painting, \$5,488
- b. Glen Royals, 187 S. Main St, Repair Brick and Façade, \$25,000
- c. Sherrie Pergola, LLC, 247 N. Elm Street, Storefront renovations, lighting, roof, and wall repair to include new decorative post and architectural detail on top of the parapet, \$25,000
