Dear Sir or Madame:

If you buy ammunition for your Department, whether you are the Chief, Sheriff, Prosecutor, District Attorney, Warden, Firearms Instructor, or any other billet, and are looking for a reliable source and excellent prices, you need to read this. We have been in business at the same location since 1930 (approximately 90 years) and are located approximately three miles from downtown Philadelphia as the crow flies on the New Jersey side of the Delaware River. We have the current New Jersey State Contract for Federal ammunition, Remington ammunition and firearms, Speedwell paper targets, PMC ammunition, PolyFrang ammunition, Benelli firearms, Heckler & Koch firearms, MACE, EOTech, Walther firearms and other items. We have the current New York State Contract for Federal ammunition, Remington ammunition and firearms, Heckler & Koch firearms, Walther firearms and other items, the New Hampshire State Contract for Federal and CCI/Speer ammunition, the Maine State Agreement (Contract) for Federal and CCI/Speer ammunition, the NYPD Contract for Federal rifle ammunition, and a lot of other Contracts. Enclosed with this letter is my current Connecticut State Contract price list with representative prices for Federal Cartridge, CCI/Speer, PMC, and Remington ammunition which we are offering to all Federal Excise Tax exempt agencies in the State of Connecticut. Federal agencies, private security agencies, and private college security/police who are not exempt from the Federal Excise Tax would have to add the FET back in to the prices (FET-OUT price X 1.11). Again, the prices include the

freight, tailgate delivery, for a factory drop ship from the Manufacturer to your Connecticut Department location. Also enclosed are representative prices for Speedwell Paper Targets.

We also have very competitive prices for Remington, Benelli, Walther, Heckler and Koch, Springfield Armory, and other firearms. Please get a quote from us if buying new weapons. We take all lawful weapons (rifles, shotguns, pistols, revolvers, gas guns, flare guns, BATF Form 5 transferable sub-machine guns and machine guns, swords, bayonets, etc., new or used, pristine or beat up, military or civilian) in trade for credit against everything that we sell. That includes weapons you bought, confiscated weapons, and donated weapons (what I normally call dead guy stuff from family members that have no interest). Please get a used weapon quote from us before you turn something into a manhole cover in Hartford that you could have converted into new equipment for the Department.

We are open five days a week, Monday through Friday, from 0730 to 1600. We accept orders either mailed via US Mail OR via Emails OR via Fax OR we will take orders orally over the telephone. Our telephone and fax numbers and email address and mailing address are all listed at the top of this letter. There is no minimum or maximum order BUT ammunition must be ordered in full case lots and we have quoted by the case. Just use the Unit prices provided to determine your totals. We accept payment via voucher and check OR by EFT/ACH and can provide Bank information/Route number/Account number on request. Invoices are NET 30 days after receipt of product or invoice, whichever is later.

Everyone (except non-tax exempt Federal agencies/private security) is required to sign a Federal Excise Tax Exemption Certificate for the purchase of ammunition and firearms (one for each brand) which we provide at the time the order is placed which says it is for the agency and not being purchased for the purposes of resale. They must be mailed with original signatures, preferably in blue ink, and cannot be faxed or emailed once they are signed. IRS rules, not ours, and chiseled in granite.

As for me, I am third generation in this business. I put over 23 years in the Marine Corps, Active and Reserve, and retired as a Major. I was an Assistant Prosecuting Attorney for a number of years in Gloucester County, New Jersey and taught New Jersey and Federal firearms law at the Gloucester County (NJ) Police Academy for 26 years and also taught at the Camden County (NJ) Academy on an as needed basis during the same time period. I am a member of the Pennsylvania and New Jersey Bars (both active), and Ohio Bar (inactive) plus four Federal bars (active). Bottom line, we know the law enforcement business. And we supply a large % of the Departments in Connecticut already so if you are not already buying from us, it is very easy to just call around and check us out.

And that's about it. We appreciate your business.
