RE: Streetlight Maintenance Contract

In 2010 the City of Torrington advertised for proposals for our Streetlight Maintenance Contract. The contract was awarded to Turri-Masterson, Inc of Torrington. The initial term of the contract was five (5) yrs., with the provision of extending the contract in annual increments for an additional 5 yrs. This resulted in a contract expiration date of 6/30/2020. Unfortunately, I did not realize the contract had expired and over the past two (2) years the contract was renewed.

Due to the timing I do not feel that we have sufficient time to put this contract out to bid, perform the bid evaluations and present the bid for approval, and execute a contract before July 1, 2022.

In recent communication with Turri, Turri is agreeable to extending the contract for an additional year.

Base Maintenance Cost: Increase by 1% (\$613.37-\$619.50) an increase of \$6.13/month for an annual increase of \$73.56.

Emergency Repair Services, Replacements and New Installations: These services are provided on a time and material bases. Turri is agreeing to hold the current rates. Turri has been our Streetlight Maintenance for the past 22 years and has provided excellent response and service at a reasonable cost.

It is my recommendation to accept the terms as proposed and extend the Streetlight Maintenance Contract and award to Turri-Masterson of Torrington for the period 7/1/2022 - 6/30/2023.
