

## **Old Business:**

- 1. The VSO had applied for a 501C3 Tax Exempt status. A required report has been filed online with the Secretary of State which is due June 02,2022. The VSO is now registered with the State of CT. as a non profit. Waiting on confirmation from the Fed. Confirming that we are a 501-3C, it can take up to 90 days for approval.
- 2. The term of Chairman expired in April 2022. An election is required at the May meeting.
- 3. VSO By-laws state's that the director of the VSO is required to be a veteran and that the assistant director is also required to be a veteran.
