Hi Carol,

I would like to add the following item to the City Council Agenda for Tuesday Sept 5th.

The current Frontier Communications contract for the City's Wide Area Network (WAN) is expiring in September 15th 2017. The WAN services allow municipal sites to access the City's business applications and the Internet. The IT Department is requesting City Council's approval to renew Frontier's contract for WAN services. The new contract terms provide:

- 1) Increased in bandwidth for faster data transmission.
- 2) Redundant Internet connection for Public Safety.
- 3) Cost reduction of \$1,008.75 per month or \$12,105 per year.

The new contract term is the same: 60 months.
