Describe the product or service to be purchased:

The P354 crawler camera system with the 6-inch tractor and the P350 fixed elevator assembly (MK2) that connects to our CUES (formerly Pearpoint) Flexitrax C550c CCTV system will allow us to enter sanitary line that are too small for the WPCA's current crawler(P356). It will also allow the Collection crew to continue to run the CCTV system when the P356 crawler is down for repairs.

We must use Crawler camaras that are accessories to our CUES (formerly Pearpoint) system. CUES only offers their products through their regional distributors. Baher Sales, Inc out of Wallingford, CT is their regional distributor and a vendor of record for the City of Torrington since 2001.

The total cost for P354 crawler camera system with the 6-inch tractor and the P350 fixed elevator assembly (MK2) is \$18,032.00.

I recommend that we purchase the 350 NTSC pan and tilt crawler camera with 6" tractor to efficiently continue to maintain our sanitary pipe inspections.
