A **REGULAR MEETING** of the City Council & WPC Authority was held at the City Hall Auditorium on Tuesday, January 22, 2019.

Present were Mayor Elinor Carbone and City Councilors Marie Soliani, Frank Rubino, Fred Simon, Gregg Cogswell, Anne Ruwet, and Paul Cavagnero.

Also present were Corporation Counsel Atty. Victor Muschell and Director of Public Works Jerry Rollett.

Mayor Carbone called the meeting to order at 6:32 p.m.

#### **Minutes**

On a motion by Councilor Simon, seconded by Councilor Cogswell, the Council voted unanimously to accept the minutes of the Regular Meeting held January 7, 2019.

### Open to the Public

On a motion by Councilor Rubino, seconded by Councilor Soliani, the Council voted unanimously to open the meeting to the public.

Ray Bottass expressed his concerns regarding Woodridge Lake Sewer District and potential litigation between the City and Harwinton. He also wished Mr. Rollett good luck in retirement.

#### **Mayoral Appointments**

On a motion by Councilor Cogswell, seconded by Councilor Rubino, the Council voted unanimously to reappoint Jessica Magda and Jessica Wright to the Torrington Area Health District Board of Directors for a three-year term to expire January 9, 2022.

### Vintage Light Repairs

On a motion by Councilor Ruwet, seconded by Councilor Cogswell, the Council voted unanimously to accept the recommendation of the Public Works Director, and authorize Melnick Metal Works, Inc. of Bristol, CT to complete the repair of two vintage light fixtures in the amount of \$5,800 to be paid from the facilities contingency line item, as described in Jerry Rollett's memo dated January 9, 2019.

The Council expressed their concerns regarding the cost of the repair. Mr. Rollett explained that the light fixtures are exceptionally old and large. He described the work that is needed to repair them, and added that the Torrington Historical Society would not allow the City to replace the lights with new fixtures.
