A **REGULAR MEETING** of the City Council & WPC Authority was held at the City Hall Auditorium on Monday, April 15, 2019.

Present were Mayor Elinor Carbone and City Councilors Frank Rubino, Gregg Cogswell, Anne Ruwet, Marie Soliani, Paul Cavagnero, and Fred Simon. Corporation Counsel Atty. Victor Muschell, Public Works Director Ray Drew, City Engineer Paul Kundzins, City Treasurer Dan Farley, and Police Chief William Baldwin, Jr. were also present.

Mayor Carbone called the meeting to order at 6:49 p.m.

Roll Call Vote

On a motion by Councilor Cogswell, seconded by Councilor Cavagnero, the Council discussed tabling the vote to approve amending the Code of Ordinances by adding an ordinance regarding the sale of tobacco and vaping products to a later date.

On a motion by Councilor Cogswell, seconded by Councilor Ruwet, the Council voted unanimously to table the vote to May 6, 2019 at 6:30 p.m.

Minutes

On a motion by Councilor Cogswell, seconded by Councilor Cavagnero, the Council voted unanimously to accept the minutes of the regular meeting held April 1, 2019.

Open to the Public

On a motion by Councilor Soliani, seconded by Councilor Rubino, the Council voted unanimously to open the meeting to the public. No one from the public wished to speak.

Addition of Section B

On a motion by Councilor Cogswell, seconded by Councilor Cavagnero, the Council voted unanimously to add "Section B" to the agenda.

Section B

On a motion by Councilor Cavagnero, seconded by Councilor Simon, the Council voted unanimously to reappoint Susanne Emmons as a regular member of the Board of Assessment Appeals for a three year term to expire on December 6, 2021.

On a motion by Councilor Cavagnero, seconded by Councilor Cogswell, the Council voted unanimously to reappoint Patricia Ward as an alternate member of the Board of Assessment Appeals for a three year term to expire on December 6, 2021.

Municipal Development Plan

On a motion by Councilor Soliani, seconded by Councilor Ruwet, the Council voted unanimously to accept the recommendation of the Torrington Development Corporation (TDC) and reapprove the Municipal Development Plan (MDP) in accordance with section 8-189(b)(2) of the Connecticut general statutes.

Peter Herbst, Esq. spoke on behalf of the Torrington Development Corporation to recommend that the City Council reapprove the MDP. Councilors Soliani and Ruwet expressed their support for the MDP and the TDC.

Collective Bargaining Agreements

On a motion by Councilor Rubino, seconded by Councilor Cogswell, the Council voted unanimously to approve the three year City of Torrington and Torrington City Hall Employees, Local 2212 AFSCME, Counsel 4, AFL-CIO Successor Agreement commencing July 1, 2018 and expiring June 30, 2021.

On a motion by Councilor Cogswell, seconded by Councilor Simon, the Council voted unanimously to approve the three year City of Torrington and Torrington Public Works Employees, Local 2212 AFSCME, Counsel 4, AFL-CIO Successor Agreement commencing July 1, 2018 and expiring June 30, 2021.

Road Reconstruction Contract

On a motion by Councilor Cogswell, seconded by Councilor Ruwet, the Council voted unanimously to accept the recommendation of the City Engineer and Deputy Public Works Director to award the contract for the reconstruction of various roads, as described in Paul Kundzins' memo dated April 11, 2019, to Waters Construction Company of Bridgeport, CT for \$2,611,359.90 and authorize the Mayor to act on behalf of the City regarding the award and execution of the contract agreement.

Councilor Rubino asked if the road construction associated with the contract was part of the pavement management program which received authorization for bonding at the November, 2018 referendum.
