A **REGULAR MEETING** of the City Council and Water Pollution Control Authority (WPCA) of the City of Torrington was held at the City Hall Auditorium on Tuesday, September 6, 2022. Present at the City Hall auditorium were Mayor Elinor Carbone, Corporation Counsel Victor Muschell, and City Councilors Drake Waldron, Paul Cavagnero, and Anne Ruwet. City Councilors Armand Maniccia, David Oliver, and Keri Hoehne joined via Zoom. Also present at City Hall were, City Planner Jeremy Leifert, Assistant City Planner Nate Nardi-Cyrus, Economic Development Director Rista Malanca, WPCA Administrator Ed Tousey, Treasurer Dan Farley, Facilities Director Jamie Sykora, IT Director Gerry Crowley, Fleet Manager Emil Castro, and Torrington Housing Authority Director Claudia Sweeney. Police Chief William Baldwin, Police Capitan Bart Barown, Public Works Director Ray Drew, and City Engineer Paul Kundzins joined via Zoom.

Mayor Carbone called the meeting to order at 6:35 p.m. beginning with the Pledge of Allegiance.

#### **<u>Public Comment:</u>** (in-person only)

On a motion by Councilor Waldron, seconded by Councilor Cavagnero the Council voted unanimously to open the meeting to the public, in accordance with Section 4(e) of the City Council & WPCA Meeting Rules of Procedure.

<u>Tom Kandefer</u> spoke about the City Wide Clean up coming up on September 17, he also talked about other upcoming events in Torrington, like Octoberfest.

<u>Steven Ivain</u> shared his thoughts on the proposed Torrington Housing Affordability Plan.

## **Approve Minutes**

On a motion by Councilor Maniccia, seconded by Councilor Waldron, the Council voted unanimously to accept the Regular meeting minutes from August 15, 2022.

## Set a Public Hearing for Sewer Benefit Assessment for Homestead Rd and Kimball Lane

On a motion by Councilor Ruwet, seconded by Councilor Cavagnero the City Council herein acting as the Water Pollution Control Authority, pursuant to C.G.S. §7-250 voted unanimously to set a date of October 3, 2022, for a Public Hearing for the Sewer Benefit Assessment for properties on Homestead Road and Kimball Lane.

# Avs-026-070722 Audio Video Solution for City Hall Auditorium

On a motion by Councilor Ruwet, seconded by Councilor Cavagnero, the Council voted unanimously to accept the recommendation of the IT Director, Public Works Director, and Facilities Manager to award the contract for the installation of upgraded Audio-Visual equipment for the Auditorium at City Hall, to Sound Works and Security of Torrington, CT for \$242,485.90 and authorize the Mayor to act on behalf of the city regarding the award and execution of the contract agreement, funding will be from ARPA Funds and IT Capital. Councilor Cavagnero asked what the City would be getting for \$242,485.90, IT Director Gerry Crowley explained all of the different items that would be getting upgraded in the Auditorium. Councilor Cavagnero also asked if this had gone out to bid, and Mayor Carbone let him know that it had. Councilor Ruwet asked if there would be any portable equipment included, IT Director Gerry Crowley explained that it was only for the Auditorium right now but could investigate adding portable equipment in the future. Councilor Waldron asked if there would be permanent displays, IT Director Gerry Crowley said that there would be two permanent monitors facing the audience and that each Council member would have a screen.

Councilor Hoehne joined at 6:47 p.m.

# Proposed Torrington 2022-2027 Housing Affordability Plan

Presentation of State mandated (CGS Section 8-30J) Affordable Housing Plan for the City of Torrington. Jeremy Leifert, City Planner, introduced Jocelyn Ayer, Director, Litchfield County Center for Housing Opportunity. Ms. Ayer explained that every state is required to have a housing plan. She went on to highlight how the plan was developed, and the goals and strategies that the plan would like to achieve over the next five years. Ms. Ayer mentioned the different housing stock in the City that would qualify for Affordable Housing, with some new units coming soon. Councilor Ruwet congratulated the Committee for working on this plan for the last year, she went on to say that she would be reading the plan in detail before the next meeting. Councilor Cavagnero asked for a clear definition of Affordable Housing, Ms. Ayer explained that they use the State's definition of Affordable Housing, since it is a State mandated plan. Councilor Cavagnero also asked if there was any way to keep Section 8 out of projects so that the seniors and veterans were protected, Torrington Housing Authority Director Claudia Sweeney stated that there is no way to keep Section 8 out of a housing project as it is illegal, however, they are working on a plan to have a space specifically for seniors and veterans.

On a motion by Councilor Maniccia, seconded by Councilor Cavagnero, the Council voted unanimously to rescind the August 15, 2022 vote to reappoint Christine Altman (D) and Tomasz Kalinowski (L) as regular members of the Inland Wetlands Commission for three-year term set to expire September 4, 2025. This is to correct the Commission name.

On a motion by Councilor Cavagnero, seconded by Councilor Hoehne, the Council voted unanimously to o reappoint <u>Christine Altman</u> (D) as a regular member of the <u>Inland Wetlands Commission</u> for a three-year term set to expire on September 4, 2025.

On a motion by Councilor Cavagnero, seconded by Councilor Ruwet, the Council voted unanimously to reappoint <u>Tomasz Kalinowski</u> (L) as a regular member of the <u>Conservation Commission</u> for a three-year term set to expire on September 4, 2025.

## **Veteran's Advisory Committee**

On a motion by Councilor Ruwet, seconded by Councilor Cavagnero, the Council voted unanimously to reappoint Michael Thomas (R) and Dennis Bailey as members of the Veteran's Advisory Committee for a second four-year term set to expire September 30, 2026.

Julie Scharnberg spoke about the process that the ARPA Committee went through for processing the applications, with the eligible programs, and having a scoring rubric based on 100 points. Ms. Scharnberg explained how the ARPA Committee split up the applications for the first round of grant requests into three parts, with this being the first phase with requests being under \$15,000. Councilor Cavagnero asked if there would be a website or link available for residents to see the requests and what the companies intend to spend the funds on, Ms. Scharnberg explained that the ARPA Committee would speak about the best way for a post-grant report to be made available for City residents.
