Regular Meeting

- 1. Call to Order: 6:30pm, Land Use Office, Room 324,140 Main Street, Torrington, CT.
- 2. Roll Call & Announcements: Members: Chris Altman, John Czapor, Jim Fedorich, Tomasz Kalinowski, Kevin Finn & staff Rista Malanca

3. New Business:

a. Request from Healthport, LLC, submit report to Planning and Zoning regarding zone change application on parcel with conservation easement in favor of the City of Torrington Conservation Commission – 61 Commercial Blvd.

Peter Herbst, Craig Chasse, Travis Andregetti - Attorney Herbst gave a presentation regarding this matter. The applicant is applying for an overlay zone to allow for a medical marijuana in existing building. The application requires Conservation Commission to review prior to P&Z approval to ensure proposal is consistent with the conservation easement on property. The Commission reviewed the easement language. Attorney Herbst stated that there is no activity proposed outside of the building, or site changes. Architect Mr. Chasse confirmed that there is no exterior modification proposed. Parking is adequate to meet zoning regulations so there will not be any parking added to site to accommodate this change of use.

Motion made by Mr. Czapor seconded by Mr. Kalinowski favorable report to P&Z as this application is in compliance with terms of the conservation easement filed on the land records vol 1007 page 0598 – unanimous.

Motion made by Ms Altman second by Mr. Kalinowski vote to add to the agenda discussion of purchase of pan am parcel. The Commission is aware of the purchase of this property and had no question or concerns and is in favor of purchasing this property.

Motion by Mr. Czapor seconded by Mr. Fedorich Support the purchase of the pan am property and consistent with the plan on conservation and development - unanimous
