## Section 3.0 USES

## 3.1 Table of Uses

Table 1 of this section is part of these regulations. Land and structures shall be used for one or more of the uses specified in Table 1.

Any use not specified is prohibited.

The symbols in Table 1 mean the following:

p - use permitted;

e - use permitted by special exception;

p/e - use permitted by either special exception and site plan or site plan

only depending on conditions specified in Addendum: Wireless

Communication Facilities:

p/z- use permitted with zone change and site plan dependent on

specific site location criteria specified in Section 4.16

blank - use not permitted.

The uses in Table 1 are classified according to a code in the first column. There are twenty one major use classifications - e.g. 9.0 Parking & Storage. These classifications are also used in Section 5.13 to indicate the number of required parking spaces.
