GENERAL DESCRIPTION OF THE PROJECT

The project work is comprised of furnishing all equipment, labor, material, plant, and superintendence to perform all work necessary for the improvements to convert the westerly section of existing Franklin Street into pedestrian plaza including new concrete and brick sidewalks, granite and concrete curbing, tree planters, lighting, landscaping, parking lot and street paving as associated works, and designated as “**CITY PARKING LOTS**” for the City of Torrington.

PREPARATION OF BID

Each bid must be submitted on the prescribed forms. No other form of Bid shall be acceptable. All blank spaces for bid prices must be filled in, printed in ink or typewritten, in both words and figures. **In the event of any discrepancies between written words and figures in connection with any Bid item, the words shall prevail.** The envelopes containing the bids must be sealed, addressed to the City Purchasing Agent, City of Torrington, Torrington, CT and designated as “**CITY PARKING LOTS**”

Each bid must be submitted bearing on the outside of the envelope, the name of the bidder, and his address. If forwarded by mail, the sealed envelope containing the bid must be enclosed in another envelope addressed as specified in the paragraph above. Conditional bids will not be accepted. Only complete bids will be accepted.
