 It states to run 2 strand/multimode fiber between headend 1 and headend 2. Is this correct?
 - Yes, that is correct. The fiber will provide the full 10GB bandwidth betwen the two network switch SFP ports
- 2 Is raid required or a battery backup for the requested BCD servers?
 - Yes. Please provide for RAID 5. No battery back-up is required other than the specified UPS units.
- 3 For the trench, how deep does it need to be dug to run our pipe over to the pole?
 - It is each installing company's responsibility to determine that information and comply with all state and local codes.
- 4 Will Prevailing wage be required for this bid?
 - For the purpose of this bid, please base the bid forms on regular rates and include an add alternate for the increase, should prevailing wage rates be required.
- 5 Will the City of Torrington wave the permit fee for this project?
 - A permit will required and this fee is waived by the city. However, the state fee is collected @ 26 cents per \$1000.
- 6 Does the 6% advantage for Torrington based company also apply to Torrington property owners?
 - "City-based bidder" shall mean a business with a legal principal place of business located within the City of Torrington. 
