Mr. Leifert updated Commission members on the status of this lot, it is a building lot and no actual engineer's plan has been submitted for approval of house construction. Work and disturbance is occurring on the property.

Mr. Nardi-Cyrus updated the Commission with evidence and photographs, in the file. There are photos in the file of grading within the wetlands.

Mr. Leifert reviewed the procedures for a show cause hearing.

Property owner Mr. John Sliwa appeared and explained what he is working on at the property site. Mr. Sliwa stated he has permits and approvals for everything he is doing on site, and he has the right to use his property.

Mr. Leifert explained an approved Zoning Permit and engineered plans are needed before any work is done on a vacant building lot. Now there is storage of equipment, site disturbance and pesticide spraying on site (not by a licensed provider). Mr. Sliwa disagreed. Mr. Sliwa stated he does not have the funds for a new house, and engineered plans.

The Commission unanimously agreed to give Mr. Sewell thirty (30) days to remove all equipment from the site.

MOTION by Ms. Altman to allow the Cease and Desist Order to remain in place, and to give the property owner thirty (30) days to remove all equipment from the site:
