b. Proposed Amendments to Torrington Zoning Regulations

Proposal: Section 5.19; Temporary and Limited Moratorium on Cannabis

Mr. Mele opened the public hearing at 7:29 p.m. and stated serving on the Commission this evening are Commissioners Jim Bobinski, Tom Telman, Starley Arias, Donovan Riley, Greg Perosino and Greg Mele. Also present is City Planner Martin Connor.

Mr. Mele read the legal notice of public hearing which was published in the Republican American.

Mr. Connor explained the temporary and limited moratorium being proposed, the effective dates would be September 25, 2021 through September 25, 2022, unless this Commission adopts regulations on Cannabis establishments prior to September 25, 2022.

Mr. Mele opened the public hearing for comments in favor of the proposal. (the first speaker was against the proposal, not in favor.)

Michael Niprahl, 408 Clearview Avenue, appeared against the proposal, and commented about the lottery that would be available from State of Connecticut for potential retailers, and hoping the town does not miss out on this opportunity to receive 3% tax revenue. Mr. Niprahl will be pleased to donate funds from his sales for community programs.

No speakers in favor of the proposal. Mr. Mele opened the public hearing for comments against the proposal.

Tom Macre, 3568 Winsted Road, Torrington, owner of Still River Dispensary appeared before the Commission. He stated he is the owner of the Still River Dispensary. He asked for a six month moratorium instead of one year.

Emily Szabo, 6 Hyde Road, Farmington, CT appeared, she represented United Food and Commercial Workers Union, who represents workers in the cannabis industries. She is here in support of Still River Dispensary.

There were no other public comments.

Mr. Perosino inquired about the lottery mentioned by the first speaker. Mr. Connor explained the number of retail facilities that will be allowed by the State of Connecticut will be determined by the population numbers of each individual town. Mr. Connor stated the purpose of this moratorium is to prepare plans and regulations for such operations.

Mr. Perosino does not see a problem with the one year moratorium, and this Commission should make it a priority to come up with plans and regulations.

Mr. Connor noted the Mayor is working with the Police Chief to come up with an ordinance regarding the use of marijuana in public spaces. Mr. Perosino stated the City is not opting out of retail sales, just working to come up with the best plan possible for all involved.

Mr. Connor noted the City of Torrington will not be able to stop delivery of the product, but if we don't have a retail facility, we will not receive the 3 percent tax. He noted the Commission did a careful job with the medical marijuana regulations, and an overlay district was proposed, and there have been no problems with the one facility the town does have.

Mr. Riley noted the key words are temporary and limited, and this gives us a chance to do this in an orderly fashion and involve the Police Chief, etc.

Mr. Mele closed the public hearing at 7:48 p.m.
