RE: Blight Enforcement Update	

Notes/Comments:

Below is a summary of blight enforcement properties and the different stages they are in. All files are reviewed by the Blight Task Force. Attached you will find the City's active blight log along with a list of properties brought into compliance.

Enforcement cases sent to Corporation Counsel for legal action:

- *Note all enforcement was prepared and ready for legal actions when the Global Pandemic Covid-19 brought our systems to a halt until further notice. *
 - 1. <u>126 High Street</u> Enforcement history dates back well over a long period of time. More recently started again in 2018 for junk/debris, overgrowth, the structure to be in disrepair, & abandonment.
 - 2. <u>62 Highland Ave</u>- Enforcement started in March of 2020 for debris/junk, overgrowth, some disrepair to the home, and a dangerous tree.
 - 3. 1167 Highland Ave- Enforcement started July 2019 for collapsed barn, and overgrowth.
 - 4. <u>64 Maplewood Ave</u>- Enforcement started December 2018 for Junk/debris, unreg. Vehicles, structure in disrepair, and water damage to front porch.
 - 5. <u>161 N Chapel St</u>. –Enforcement started April 2019 for Debris/junk, abandonment and overgrowth.
 - 6. <u>590 Newfield Spring Rd</u> Enforcement started December 2017 for junk/debris, several unreg. Vehicles, and peeling paint.
 - 7. <u>2152 Norfolk Rd</u> Enforcement started July 2018 for overgrowth, junk/debris, disrepair to the home, and vandalism.
 - 8. <u>170 Park Ave Enforcement started January 2019 for junk/debris, unreg. Vehicles, and disrepair.</u>
 - 9. **286 Park Ave-** Enforcement started May 2019 for junk/debris, unreg. Vehicles, boarded up home, peeling paint, and overgrowth.

- 10. 21 Pearl St Enforcement started August 2018 for debris/junk, peeling paint, nuisance.
- 11. <u>492 Prospect St.</u> Enforcement started December 2019 for several unreg. Vehicles, junk/debris, and overgrowth.
- 12. <u>70 Red Oak Hill</u> Enforcement history dates back well over a long period of time but recently picked back up July 2019 for junk/debris, unreg. Vehicles, disrepair to the property and home, over growth.

Enforcement cases currently waiting or scheduled for a hearing:

1. <u>80 Workman Ave – Enforcement started May 2019</u> and was brought to a hearing where the property was then brought into compliance. In January 2020 the file was re – opened when it was noticed the property had fallen out of compliance with the City's codes. Citations started March 2020 and a request for a hearing followed shortly after. Due to Covid-19 we were unable to schedule a hearing until recently. Hearing is expected to be held in January 2021.

- <u>Cases brought into compliance since January 2020</u> 57 cases (2019 -34 case, totaling 91 properties)
