On 03/11/22 at approximately 1144 hours, I (Officer Zambetti) was dispatched to 441 Oak Avenue for a report of harassment.

Upon arrival I met with Elizabeth Tieman [redacted] who stated she attempted to gain her neighbors attention, later identified as Gary Hatstat [redacted]. Tieman stated she was going to ask Hatstat to lower the music he was playing outside his place of business. Tieman stated Hatstat refused to speak with her and continued to ignore her. Tieman stated she does not want further issues with Hatstat. Tieman also stated Hatstat continuously ignores her when she tries to speak civilly with him.

I then spoke with the caller, Hatstat who stated Tieman approached him and called his name. Hatstat stated he ignored Tieman and she went back inside her residence. Hatstat stated he called the Police Department because he wanted to document the incident because she has tried to bother him on multiple occasions and he does not want to interact with Tieman.

Both parties were then told to limit their contact with one another and advised to contact the Police Department if any further issues were to arise.

A COLLECT check revealed no warrants or orders between either party involved.
