The attached information is my proposed request that the Torrington Police Department be allowed to enter into a 10 year contract with our current vendor, Axon, for our BWC (Body Worn Camera) and Taser's. We are currently at the half way point in our current contract which is set to expire on June 30, 2022.

By entering into a new agreement, we will be able to carry out our mission of transparency and officer safety into the next decade at a considerable cost savings to the city. Axon is the standard in this type of equipment that is not only necessary for our officers in this present environment, but will more than likely be legislated for all police agencies into the near future. Additionally, by entering into this agreement, the Torrington Police Department will be the recipient of needed and current technology, to include significant and necessary add-on's to our current status.

Sgt. Greg Wityak was directed by me to research and pursue the proposal that is attached. I want to personally thank Sgt. Witvak for his painstaking work that he did concerning this project. Sgt. Wityak is the subject matter expert in this area and was able to work with our vendor to submit a proposal that will be beneficial to our city in many different facets.

Proposed 10 Year Axon Contract with the City of Torrington

The city and police department entered into a 5-year contract with Axon July 2017. With the inception of the agreement we had 58 licensed users at a cost of \$54,788. In 2019 it became apparent we needed to expand the number of users to 68 which allowed us to include all the members of the Detective Division. The yearly payment increased to \$59,487. As time has passed and more videos have been created the amount of Freedom of Information Requests has dramatically increased for our digital evidence. All videos need to be reviewed and certain information must be redacted and obscured from view. This is a very tedious and time-consuming process. Axon has embedded redaction software within Evidence.com, but they also have an Artificial Intelligence (AI) driven Redaction Assistant which speeds the redaction process 10-fold. This add-on module cost \$14,400 per year and was added into the department's 2020/2021 budget. With this addition, our yearly contracted price with Axon is \$73,886.

To do a true comparison of the proposed contract we obtained cost breakdowns for what our current contract's value is in 2020 dollars. We were surprised to find our current contract's initial value of \$54,788 had jumped to value today of \$78,144, an increase of \$23,366 in just 3 years. By looking at these numbers we can assume an annual increase of 9% for the Axon products. Axon themselves have stated to us that they believe there to by an increase of 10% to 12% per year moving forward. Axon claims by going to the new Officer Safety Plan (OSP 7+) and purchasing the all the features as a bundle we will have a 32% savings over what the total cost would be purchasing the items al-a-cart. Axon has agreed to hold the cost of the first 2 years of a new contract the same as the final 2 years of our current contract, \$73,866. By holding the dollar amount in the first two years of the contract the city we will be saving approximately \$150,000 in costs, but still have every feature of the new OSP 7+.

Since the onset of the department entering into the contract with Axon, we have steadily been transferring all of our digital evidence over to the Evidence.com platform. One feature of the proposed contract is the addition of 500 GB of external storage per officer. This storage, approximately 40 TB in total, will be entered into the total storage available for our department. As a point of reference, in the two and a half years of total department activity in the Axon system, we have only used 25 TB in total. This additional 40 TB of data will be added anew at the start of every year of the contract. Bottom line we will never run out of data space! Since no other company that offers a body camera system can even come close to the amount of storage or the price of the storage, it is in the city's best interest to stay with Axon.

By having this massive amount of external storage, (digital data created outside of the Axon environment), we will be able to transfer and store all Interview Room videos recorded from our non-Axon system into Evidence.com and assign it to all digital evidence that has been created for the incident to date. We have already been in the process of phasing out a digital storage program called Vir-A-Pic in the Detective Division. Phasing out this program will be a saving to the department of approximately \$3,300 a year, this translates to a \$33,000 saving over the proposed 10-year contract with Axon which can be added to the payment.

Another component of this system is the Taser, which is also subject to an upgrade with this proposed contract. Our department currently carries the Taser X-26P and has for the length of

the current contract. These weapons, along with any other Taser manufactured carries a 5-year operational warranty. Our current weapons are approaching the end of their service lives and will need to be replaced in 2 years. The Training Division budgets approximately \$10,000 per year for the purchasing of batteries and cartridges for the Taser units. The costs of these items are subject to a 5% cost increase per year as stated by Axon. With the proposed OSP 7+, we would have all Taser batteries and cartridges included for the entire length of the contract. If a duty cartridge is fired, Axon will replace the cartridge free of charge. By going with the program and obtaining the new Taser 7 weapon units, the department will save approximately \$137,854 over the term of the new contract. This proposed savings would be earmarked to help pay the yearly cost of the contract.

This contract is set up as two, five years contracts. The reason for this is because several of the items we are purchasing have 5-year service limits at which point the warranties expire. The Taser weapons will all be refreshed at this point, Year 6, and we will receive the latest model available. Other items which have been purchased such as holsters and mounts will need to be repurchased at this point. This is the reason why Year 6 of the contract has a large increase. The size of the increase, approximately \$16,000, was absorbed by Axon in Year 1 of the contract when our price will be held at our current payment. Prior to Year 6, the contract can be refined or reworked similar to our current circumstance. While it is extremely cost affective to tie into this 10-year deal, new products and innovations will always be available for us to add in or rework to obtain. Just because we have a 10-year contract does not mean we will be operating with old, outdated equipment. We would receive the newest model body cameras in years 1, 3, 5, 8 and 10 as well as the newest Taser in years 1 and 6. The hardware the cameras and Tasers dock into to download and charge would also be replaced at the same rate in which their devices were replaced.

I truly believe this plan is an intelligent and prudent thing for both the city and department to undertake at this juncture. As recent events have shown us the ability of a city and department to be as transparent and open as possible is a huge key in gaining and keeping the public's trust. Since the beginning of our involvement with Axon's Tasers and body cameras, our use of force incidents have declined and citizen complaints against officers have decreased dramatically. A large part of this new contract is surely the saving the city will enjoy, but the new technology and software this program has to offer will surely help move our department forward as a leader in the state for officer accountability and safety, a part that simply cannot be overlooked.
