Re: Ballistic Rifle Plates

The Torrington Police Department is requesting to accept the ballistic rifle plates bid from Tactical Police Gear in Cheshire, CT., for the Special Response Team. The Special Response Team looked at the ratings and needs and determined Armor Express Tencate CR3200 Level III meets the needs of the team. The rifle plates will be replacing the current plates that all 14 team members currently wear. The rifle plates will fit inside the entry vests that are currently being purchased by the Torrington Police Department from Tactical Police Gear in Cheshire. The vests and rifle plates are used for training and call outs such as active shooter incidents and high risk warrant services. The plates that we are replacing are between 8 and 13 years old and have a five-year manufacture recommended shelf life.

The attached quote from Tactical Police Gear in Cheshire, CT., is for the NIJ compliant rifle plate. The total price for 28 rifle plates (front and rear) and shipping is \$10,920.00. The quoted price is good for 90 days. The bid will awarded upon approval from the Board of Public Safety and City Council. Funding will be from the 2020-2021 Special Squads line item.

There was a second bid that was from U.S. Patriot from Columbia, South Carolina that was for \$10, 359.72. There was a difference of \$560.28. However, it is requested that we use a local vendor and keep the consistency of having the entry vest and the rifle plates coming from a sole provider. The owner of Tactical Police Gear, Valdemar Queiroga, will come to the Torrington Police Department with the vest and plate company representative and measure the officers for proper fit.

The one-time purchase will suffice the needs of the Department and will be in use for five or more years.


